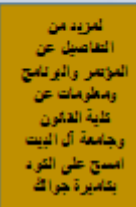

### Overview

The technical development in the digitization field has constituted one of the most significant challenges that humanity has known in its history. The expansion in the form and content of digital crime has turned into a danger that threatens life with its various implications. Closed doors are no longer a reality with the development of the form of hacking, surveillance and information espionage in various contents and forms. The economic and governmental sectors as well as personal data have become subject to infringement and violation. Thus, it is imperative to monitor aspects of this crime and search for solutions through which cybersecurity can be enhanced, whether through legal legislation, international efforts or even technical construction to protect against the endless expansion in the form and the content of digital crime in its various facets.

Basically, the idea of this conference evolved to work on monitoring the latest developments in this sector, knowing what humanity has achieved until present, and pairing and storming ideas to come up with outputs that may enhance the ability to build cybersecurity in its various technical, legal and judicial aspects.

As a culmination of this requirement, the Faculty of Law viewed it as an urgent need to invite all official, security and private sectors, including scientists, researchers and scholars to a scientific gathering. This is to discuss the above mentioned issues and come up with recommendations that might constitute an emerging building block that achieves the desired goal of enhancing cybersecurity and building confidence among the pioneers of these various sectors.

## Terms of Participation in the Conference:

- The paper shall be a recent scientific production that will be discussed in the conference for the first time.
- The manuscript shall not exceed (20) pages.
- The scientific methodology in writing research and the principles of scientific documentation shall be adhered to when submitting the paper.
- Research papers shall be printed in Simplified Arabic (14) for the Arabic language, and (12) for texts in a foreign language.
- The participant shall put a margin at the bottom of each page, with sequential numbers, and the references shall be arranged alphabetically at the end of the paper.

## Conference Fee

- Participation fees shall be (300) dollars for participants from outside Jordan, including accommodation, hospitality, transportation during the conference period, and conference publications.
- Participation fees shall be (100) dollars for participants from inside Jordan, including hospitality during the conference period, and conference publications
- Student participation fees shall be (150) dollars for each participant from outside Jordan, including accommodation, hospitality, transportation during the conference period, and conference publications.
- Student participation fees shall be (50) dollars for each participant from inside Jordan, including hospitality during the conference period, and conference publications.
- The university does not bear any costs for accompanying participants in the conference from inside or outside Jordan.
- The participant shall take care of the travel tickets and visa.
- The participant will be granted a certificate of participation and awards for the best research paper and the best panel discussion.
